Afavour4u Terms and Conditions

Booking an event with afavour4u denotes that you have read, agreed and understood these terms and conditions. No alterations to these terms and conditions can be made unless agreed by afavour4u in writing.

General

- A small non refundable booking fee of £50 to secure your day and balance due six weeks before the event. No date is secure until this payment has been received. The booking fee may only be transferred to another date upon agreement between yourself and Afavour4u, but Afavour4u is not obliged to do so.
- A £50 damage/loss deposit ideally via cheque as this is NOT cashed and returned to you within one week of the event subject to no loss or damage to any of the equipment. Should any damages occur and the amount exceeds the £50.00 deposit (this would be in the event of damage to the actual sweet cart), customer will be invoiced for the additional cost or repair. In the event of this occurring payment is to be made within 14 days of the receipt of the invoice. Damages will be charged at the appropriate cost to replace the item and proof of these costs will be provided by Afavour4u.
- The prices quoted for within our packages include local delivery in the Plymouth area, plus set up and collection of the equipment after the event. An additional fee will be charged for venues more than 20 miles from PL7 1XR. Additional mileage will be charged at 35p per mile
- If your event is in less than six weeks, the full payment is required, along with the £50 damage/loss deposit and travel fees (if necessary).
- Approximately 100g of sweets will be provided for each guest.
- For cart hire only please do not stick drawing pins or types of tape on the cart. Please use blue or white tack only.
- The cart will be put together and taken apart by afavour4u staff only.

Cancellation Fees

- Unfortunately should you have to cancel your booking within 4 weeks of the event, having paid the full balance, 50% of the total and your refundable deposit will be returned to you.
- In the unlikely event that the booking has to be cancelled by afavour4u any payment received will be fully refunded.

The Venue

- It is the responsibility of the hirer to check with the venue before booking that there is room for the equipment at the venue. Our sweet cart is approximately 5ft long and 7ft high. Please check with your wedding coordinator or party planner at the venue before booking. Please ensure adequate parking facilities are available at the venue to load/unloading of the cart and accessories.
- Please be aware that we shall need access to your venue on the morning of your event to set up the sweet cart and access again the following morning to collect the equipment if hiring for an evening event. As the hirer it is your responsibility to ensure the venue is aware of this if applicable.
- We accept no liability for any losses, injuries or damages caused to the hirer or venue, staff or guests when using our equipment.

The Confectionary

- Customers should be aware that certain hardboiled sweets and sweet wrappers may present a choking hazard, especially to young children. Please therefore ensure that any young children are supervised at all times when using the sweet buffet.
- afavour4u cannot be held responsible for any safety issues which may occur from the consumption of confectionary or the use of our equipment at your event.
- Please note that we cannot guarantee that the sweets we supply have not come into contact with or been produced in an environment that does not contain nuts. If you do have allergies, please use the sweet cart at your own discretion.
- We will do our very best to ensure that the sweets you request are included in the display however this cannot be guaranteed as they may not be available. Please bear this in mind if you have any special requests, however we will also ensure to communicate any problems which we may occur.
- Hygiene is a high priority for our customers therefore all sweets remaining at the end of your event will be packaged and given to you to take home. We do not re-use any stock.

Adverse Weather Conditions

- Please note that in the event of extreme weather conditions that deem us unable to travel to your venue, afavour4u reserves the right to cancel the booking at short notice, or even on the day of your event. In this instance you will receive a full refund immediately.

Photography/Publicity

- I would like to use images taken at events for my afavour4u gallery, please let me know if you object to this.

Complaints and Recommendations

- In the unlikely event that you are unhappy with any part of our service please inform afavour4u within 5 days of your event. We reserve the right to refuse compensation with any complaint after 5 days of the event date. Please make the complaint in writing by email to pat@afavour4u.co.uk
